In response to your request for OR Release information for the years 2009, 2010 and 2011, enclosed please find the following information. The enclosed spreadsheets were manually prepared by Anna Vasquez who had to research to obtain the data and subsequently collate that data. The spreadsheet shows those OR releases that are done from court-ordered and call-in releases by the Court. Administrative Releases are listed separately on the spreadsheet. Those are the only two breakdowns that can be provided.

Administrative ORs do not include 48-hour kick-out misdemeanors releases. Those releases are done by the jail and a request to the jail would need to be completed to receive the information. Also, court-ordered releases and call-in releases are not included in the statistics that were provided previously.
